


Figure 1: Functional Block Diagram

Description

The 8TR8211C is a compact, highly integrated frontend RFIC (Radio Frequency Integrated Circuit) intended for range extension of proprietary ISM wireless systems in the 2.4GHz band.

The 8TR8211C is optimized for battery operation with enhanced efficiency operating over a wide voltage supply range from 2.7V to 3.6V, suited for a wide array of applications including battery powered wireless systems.

The 8TR8211C combines a power amplifier (PA), low noise amplifier (LNA), a transmit / receive (T/R) switch, (Figure 1), in a 2mm x 2mm x 0.45mm 16-pin QFN package. It also comes integrated with filter networks, and input / output matching circuitry.




Figure 3:Pin Description (Top View)



Application Schematic and PCB Layout






Figure 4: 8TR8211C Reference Design Schematic and PCB Layout






Figure 5: 8TR8211C Recommended PCB Layout Footprint






Figure 8: 8TR8211C Tape and Reel Dimension
